4. Delegation(s):

- 4.1 Carmene Hampe re: Plans for the park in downtown Eagle River
 - Carmene, on behalf of a group of local Eagle River women, presented a handout to Council consisting of several long and short range ideas for upgrading this park. The following was discussed:

Railings and borders are a priority- a log fence surrounding the park and perhaps some of Burton Penner's work accenting the park would add to its beauty; an art wall; a bathroom; a flag pole and flag; solar light for the sign; dedication of the park in honor of Wilmer Errington; paint the skating rink building to match the park; upgrade the children's equipment; add at least one more bench; erect directional signage and/or a map to assist visitors seeking a specific location, i.e. Eagle Lake Reserve, Hwy 17, etc.; build a gazebo or a shelter from the elements.

- -The group is asking the municipality to keep this group in mind if any grants become available that could be applied to this project.
- -The Mayor asked if the group would consider having the rink made smaller in order to enlarge the park area — especially if more playground equipment and benches are added.
- -As for directional signage, the group was directed to contact MTO as Hwy 594 is under their jurisdiction.
- -It was suggested the group also speak to PACE to inquire whether they would fund any of these projects.

4. Delegation(s) (continued)

4.2 Kevin Welniak re: Variance for Fort Vermilion

-Mr. Welniak is requesting Council to approve, either by issuing a variance or by other means at their disposal, allowing Fort Vermilion to leave the food venue, i.e. the food truck, less than ten feet from the pavilion inside the fort, and also to agree that he can change the direction of the tent running it east-west so that people can just walk from the pavilion through the tent.

-He feels the food truck safety laws that the municipality's Chief Building Official is quoting don't apply given that by definition the food truck (which will be permanently fixed in place) is the kitchen inside the four walls of the Fort itself which makes the Fort itself the "building". He advised that SPI Safety came out and said it is perfectly safe and that all the necessary fire safety equipment is contained inside.

-Council stated that it is not within their power to issue a variance on a fire code issue; however, they will contact the Fire Marshall to ask whether he could send someone from his office to do an inspection.

-Council will also meet with Machin's CBO to discuss this issue further.
