8.3 Economic Development Report – Verbal

Max Nagy, EDO, gave Council a verbal report on the various projects he has been working on.

Will be meeting with MNRF this Friday for an update on the airport road allowances and the survey instructions for the North Cemetery expansion.

Max has started to calculate some numbers for the Lakeshore Capacity Assessment for Eli Lake and is now waiting for answers to a few questions from Ministry of the Environment, Conservation and Parks before proceeding.

Max applied and was approved for a mentorship program through the Economic Developers Council of Ontario (EDCO). This is an 8 month program that would pair Max with a person in economic development that has experience, knowledge and connections that could be passed on to Max which would help to enhance his professional development. This would allow Max to review his funding applications and projects with the mentor who could help with feedback based on their years of experience. Max would have to be a member of the EDCO the participate in the program at a cost of \$337.00 per year. Council agreed to purchasing the membership.

The CP property will need to have a Phase 2 ESA completed within the next 18 months or the Phase 1 ESA will need to be redone. The Phase 2 ESA will cost anywhere from \$15,000 to \$30,000.00.

Hydro One has a grant available focusing on physical, psychological and emotional safety. Max would like Council to consider a project that would qualify for this grant.

There are three confirmed people that would like to be on the Economic Development Committee, the 'ex-officio' member is Liz Norman from Ministry of Northern Development and Dennis Peterson will represent Council. Max plans on having a final list of committee members for the next Council meeting in January or first meeting in February, then the Committee can have their first meeting.

The piece of property in Eagle River that the Municipality is selling will be re-listed on Kijiji.

An Agreement to lease the Credit Union building was signed in December and the new tenant will be starting renovations soon. He would like to pay his rent by e-tranfer if this can be set up. Tammy will look into costs to set up e-transfers, it could make it much easier for any type of payment to the Municipality.

Carman Brignall, Machin's Recreational gave a report on current and future events that she is working on.

Tai Chi is starting this month and armchair yoga is continuing for now.

Armchair travel is travelling to Hawaii this month, this continues to be popular. The Mayor will invite Greg Rickford to attend this event.

The Dryden office of the Ontario Metis Association is planning several events to be held in the Municipality.

Dryden Native Friendship Centre is also continuing to hold events at the Eagle River Recreation Hall.
