The Lions members described the event with the activities they would like to see happen that day which include a show and shine, games, fire vehicles displayed and firefighters on hand to explain how the vehicles are used, food trucks or concession stands and a pig roast for dinner and weather permitting a bonfire at the waterfront. Most of the activities would be held at the Lions Hall with some at the Arena and some at the waterfront.

They are asking Council for a donation of \$2,000.00 to help cover some of the costs for the day. They are also asking that Council, Firefighters and Revitalization Committee members donate their time by serving a hamburger and hot dog lunch between 12:30 and 1:30.

Council has agreed to donate \$2,000.00 towards the costs for the day and will also allow the use of the Arena if needed.
